Final preliminary design

South Bank Corporation's vision for Grey Street is to create Australia's coolest and most vibrant subtropical street.

The Grey Street Bikeway and Streetscape Design project aims to transform Grey Street into a people-orientated, safe, cool and green destination. The design has been developed by South Bank Corporation, in partnership with the Department of Transport and Main Roads.

Community consultation snapshot

The final preliminary design builds on the 'Destination Grey Street' vision outlined in the Future South Bank Master Plan and has been informed by feedback on the draft preliminary design during community consultation from 27 May to 23 June 2024.

Preliminary design feedback themes

Safety: Support for slowing traffic, prioritising active transport and reducing conflicts between drivers, riders and pedestrians.

Connectivity and access: Interest in wider pathways, improved crossing points and seamless connections with surrounding cycle networks.

Accessibility: Support for raised zebra crossings and flush kerbs to help people move safely and easily.

Creating a destination: Feedback about creating spaces that encourage people to spend more time enjoying Grey Street.

Visual amenity and greenery: Support for more trees to create a cooler street.


Changes from draft preliminary design

- Widening the narrowest footpath sections to a minimum of 3 metres (widest section is 8.5 metres).
- Flush kerbs at flex-zones for improved accessibility at loading and parking bays.
- Changes to parking and loading zone positions to improve sight lines at pedestrian crossings.
- Road geometry improvements for safer vehicle turning movements and supporting coach access.
- No right-turn into Grey Street from Ernest Street to improve pedestrian safety.


